


### In Memory of Jim Erickson (1935 - 2020)

Similarly, he was a champion in helping First Hill have a strong voice at City Hall.

Besides chairing the Urban Design and Public Space Committee, he was integral to ensuring that First Hill, and other center city neighborhoods in Seattle receive commensurate public benefits as part of the Washington State Convention Center Addition. Without Jim's hard work, the Terry Avenue redesign project wouldn't have progressed as far as it has.

We owe a lot to Jim Erickson, as he helped make First Hill what it is today. The First Hill Improvement Association is committed to honoring his memory through advocacy on some of his favorite topics: ADA accessibility for pedestrians, expanding and enhancing the iconic tree canopy, adequate bicycle facilities, and reliable transit for First Hill.

If everyone committed to being as engaged as Jim Erickson was, even at a fraction of the level he was, the world would be a much better place. Jim, you will be missed!
